1) **HOW TO PAY:**

Payments to be made in Euros. For payments in other currencies, the exchange rate and the total amount will be fixed according to rates current on payment date.

2) **WHEN TO PAY:**

- a) 1 instalment **before** 15 May : 4% discount (**Tuition Fees only**)
b) 1 instalment **between** 16 May & 1 September: 2% discount (**Tuition Fees only**)
c) 2 instalments (by 1 September & 2 January): 1% discount (**Tuition Fees only**)
d) 8 instalments (monthly, 1 August to 1 March):

3) **DISCOUNTS: (Tuition fees only)**

- a) €3,500 for a family with 3 children at the school
b) €3,500 for a family with 4 children at the school
c) €13,500 for a family with 5 children at the school

OR

Discount for children of alumni of the school

- (i) 10% discount for the 1st child
(ii) 20% discount for the 2nd child, with 2 pupils at the school
(iii) 30% discount for the 3rd child, with 3 pupils at the school
(iv) 50% discount for the 4th and subsequent child(ren),
with 4 or more children at the school

DISCOUNTS applied under section 3 are not accumulative.

- 4) **DRAGON FEES:** Part-time attendance in Red Dragon can be agreed on a termly basis. Fees must be paid in advance for the whole term, according to the following rates:

- a) morning sessions: €44 each
b) afternoon sessions: €30 each
c) lunch: € 6.45 per day

- 5) **OVERDUE FEES** will carry an interest at the percentage rate equal to TUS plus 2%.
Admission of pupils to the school may not be permitted until fees and related interest charges have been paid.

- 6) **OTHER FEES:** Compulsory external examinations (Keystage, (I)GCSE, IB), compulsory educational trips, and optional programmes, such as music lessons, are all billed separately and in advance.

- 7) **CANCELLATION OF REGISTRATION:** The school reserves the right to cancel the registration of a pupil for due and just cause as determined by the Principal. Failure to comply with school regulations, terms and conditions may result in the cancellation of the enrolment of a pupil in the school without refund of the fees previously paid. In the event that parents withdraw between registration and arrival, the registration fee is non-returnable.

- 8) **WITHDRAWAL FROM THE SCHOOL:** In the case of withdrawal of a pupil from the school due to unforeseen circumstances, the school must be given 90 days notice in writing in order for a refund of fees to be given up to the end of the school year.

9) **BUS SERVICE:**

- a) School bus routes and stops are arranged to provide as convenient a service as possible within the limitations imposed by time, traffic and safety. The School reserves the right to change routes and times during the school year according to the actual situation and evolving circumstances.
b) No refunds will be made when the service is not carried out for reasons beyond the school's control.
c) The service may, by prior arrangement, be used either in the mornings or afternoons at a cost of no less than 50% of the bus fee. Other individual arrangements may be possible by prior agreement at a minimum fee of 50%.
d) Requests of daily changes of bus stops will only be accepted with at least 24 hours' written notice to the Bus Manager. Pupils can only be dropped off at existing scheduled stops.
e) Children who do not behave properly on the bus may be suspended without refund.
f) Only those pupils whose parents have completed, signed and returned the Registration Form for the use of school transport, will be allowed to use the Bus Service.
