



- **Registration fee – a non-refundable one-off payment due solely upon initial registration and also valid should the pupil leave the school and return within two academic years:**
  - **When paid by a Natural Person (i.e. a private individual): € 4.000**
  - **When paid by a Legal Person (e.g. a company, an embassy, etc.): € 5.000**
  - For registration of a third child (regardless if the other two children are still attending or not the school), a 50% discount will be applied on the registration fee for said child. For the enrolment of four or more children, please contact the School's Admissions Department.
  - The payment of the registration fee is due entirely and immediately upon the signing of this contract, EXCEPT in the following cases where payment may be deferred:
    - First registration at "Red Dragon"
      - 25% (€ 1.000 or € 1.250,00 depending on whether a natural person or a legal person) due immediately upon signing of this contract;
      - 25% (€ 1.000 or € 1.250 depending on whether a natural person or a legal person) due along with the registration to the second year ("Green Dragon");
      - 50% (€ 2.000 or € 2.500,00 depending on whether a natural person or a legal person) due along with the registration to the third year ("Year 1")
    - First registration at "Green Dragon"
      - 25% (€ 1.000 or € 1.250 depending on whether a natural person or a legal person) due immediately upon signing of this contract;
      - 75% (€ 3.000 or € 3.750 depending on whether a natural person or a legal person) due along with the registration to the second year ("Year 1")

In the event that the student entitled to the payment terms described in the above paragraph, should leave the School before completing "Year 1", the above benefit of deferment of payment will no longer apply and the balance of the entire registration fee must be paid immediately (€ 4.000 or € 5.000 depending on whether a natural person or a legal person).

In case of enrolment of a third child, the 50% discount on registration fees CANNOT be combined with the deferred payment terms of the registration fee described in the previous paragraph.



- **Re-registration fee € 350**

Payable at the start of each year of attendance except for the first year(s) in which initial registration fee is paid.

**Family discounts:**

- € 3.500 for families with 3 children at the School (ALL three children must attend the School in the same School year)
- € 8.500 for families with 4 children at the School (ALL three children must attend the School in the same School year)
- € 13.500 for families with 5 or more children at the School (ALL three children must attend the School in the same School year)

**The following payment plans are available:**

- A single payment before 31 May 2018 qualifies for a 3% discount on tuition fees only
- Eight monthly instalments to be paid at the beginning of each month from 1 August 2018 to 1 March 2019, for which there is no discount applicable

Both of the above payment plans will include tuition fees, the obligatory lunch service fee, and (if applicable) the cost of the bus service.
